

- Collaborate more securely. Data can be shared safely with co-workers, customers and partners. Users can easily define who can access the data and what they can do with it. For example, you can allow a recipient to view specific files but neither print nor forward them to others.
- Improve ease of use. MIP-defined data classification and protection controls can be leveraged by other Microsoft solutions. We

 to the network perimeter.
